**JOINT STIPULATION REGARDING SETTLEMENT OF LITIGATION
COSTS AND DISMISSAL**

STIPULATION

WHEREAS, on April 30, 2010, the Court entered an order (Dkt. #67) pursuant to which Plaintiffs are to file a motion with the Court by May 19, 2010 for a determination of the amount of their reasonable attorneys' fees and costs, in the event that the Parties have not reached a negotiated resolution of the fee issue;

WHEREAS, Plaintiffs notified the Court on May 14, 2010 (Dkt. #68) that Plaintiffs anticipated that the Court's involvement will be necessary to resolve the fee issue and Plaintiffs intended to timely file a motion to that effect;

WHEREAS, the Parties have since reached agreement (the "Agreement") on the fee issue and are in the process of performing the terms of the Agreement; and

WHEREAS, the Parties stipulate that pursuant to the terms of the Agreement Plaintiffs may file a motion with the Court in the event the terms of the Agreement are not timely concluded; and

NOW THEREFORE, the Parties, by their counsel, stipulate to the foregoing recitals and jointly request that this Court enter the following Order in this matter:

1. The deadline established in the Court's April 30, 2010 Order (Dkt. #67) for Plaintiffs to file a motion with the Court for a determination of the amount of their reasonable attorneys' fees and costs in this action is hereby extended to June 25, 2010.

2. If Plaintiffs have not filed a motion with the Court for a determination of the amount of their reasonable attorneys' fees and costs by June 25, 2010, the Court shall consider the fee issue resolved.
